Analysis is a profound subject; it is neither easy to understand nor summarize. However, Real Analysis can be discovered by solving problems. This book aims to give independent students the opportunity to discover Real Analysis by themselves through problem solving.

The depth and complexity of the theory of Analysis can be appreciated by taking a glimpse at its developmental history. Although Analysis was conceived in the 17th century during the Scientific Revolution, it has taken nearly two hundred years to establish its theoretical basis. Kepler, Galileo, Descartes, Fermat, Newton and Leibniz were among those who contributed to its genesis. Deep conceptual changes in Analysis were brought about in the 19th century by Cauchy and Weierstrass. Furthermore, modern concepts such as open and closed sets were introduced in the 1900s. Today nearly every undergraduate mathematics program requires at least one semester of Real Analysis. Often, students consider this course to be the most challenging or even intimidating of all their mathematics major requirements. The primary goal of this book is to alleviate those concerns by systematically solving the problems related to the core concepts of most analysis courses. In doing so, we hope that learning analysis becomes less taxing and thereby more satisfying. This text forms a bridge between courses in calculus and real analysis. Suitable for advanced undergraduates and graduate students, it focuses on the construction of mathematical proofs. 1996 edition. The book *Complex Analysis through Examples and Exercises* has come out from the lectures and exercises that the author held mostly for mathematician and physicists. The book is an attempt to present the rather involved subject of complex analysis through an active approach by the reader. Thus this book is a complex combination of theory and examples. Complex analysis is involved in all branches of mathematics. It often happens that the complex analysis is the shortest path for solving a problem in real circumstances. We are using the (Cauchy) integral approach and the (Weierstrass) power series approach. In the theory of complex analysis, on the hand one has an interplay of several mathematical disciplines, while on the other various methods, tools, and approaches. In view of that, the exposition of new notions and methods in our book is taken step by step. Actually, I have divided the problems into two classes called Examples and Exercises (some of them often also contain proofs of the statements from the Preliminaries). The examples contain complete solutions and serve as a model for solving

similar problems given in the exercises. The readers are left to find the solution in the exercises; the answers, and, occasionally, some hints, are still given. On the occasion of this new edition, the text was enlarged by several new sections. Two sections on B-splines and their computation were added to the chapter on spline functions: Due to their special properties, their flexibility, and the availability of well-tested programs for their computation, B-splines play an important role in many applications. Also, the authors followed suggestions by many readers to supplement the chapter on elimination methods with a section dealing with the solution of large sparse systems of linear equations. Even though such systems are usually solved by iterative methods, the realm of elimination methods has been widely extended due to powerful techniques for handling sparse matrices. We will explain some of these techniques in connection with the Cholesky algorithm for solving positive definite linear systems. The chapter on eigenvalue problems was enlarged by a section on the Lanczos algorithm; the sections on the LR and QR algorithm were rewritten and now contain a description of implicit shift techniques. In order to some extent take into account the progress in the area of ordinary differential equations, a new section on implicit differential equations and differential-algebraic systems was added, and the section on stiff differential equations was updated by describing further methods to solve such equations. This book provides an introduction to those parts of analysis that are most useful in applications for graduate students. The material is selected for use in applied problems, and is presented clearly and simply but without sacrificing mathematical rigor. The text is accessible to students from a wide variety of backgrounds, including undergraduate students entering applied mathematics from non-mathematical fields and graduate students in the sciences and engineering who want to learn analysis. The foundational material, presented in the unstarred sections of Chapters 1 through 11, was normally covered, but different applications of this basic material were stressed from year to year, and the book therefore contains more material than was covered in any one year. It can accordingly be used (with omissions) as a text for a year's course in advanced calculus, or as a text for a three-semester introduction to analysis. The prerequisites are a good grounding in the

calculus of one variable from a mathematically rigorous point of view, together with some acquaintance with linear algebra. The reader should be familiar with limit and continuity type arguments and have a certain amount of mathematical sophistication. As possible introductory texts, we mention *Differential and Integral Calculus* by R Courant, *Calculus* by T Apostol, *Calculus* by M Spivak, and *Pure Mathematics* by G Hardy.
