

THE GAME *Speel ... zolang je kunt!*

Tijdens het spel ontstaan in het midden van de tafel vier stapels met kaarten. Twee stapels stijgen in waarde (1-99) en twee stapels dalen in waarde (100-2). De spelers spelen samen tegen het spel en proberen zoveel mogelijk kaarten, in het beste geval alle 98, af te leggen op de vier stapels.

4 startkaarten

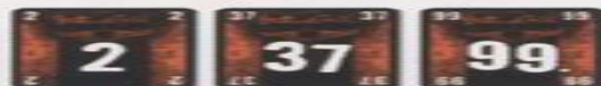


2x stijgen (1-99)

Kaarten spelen

In een **stijgende stapel** moeten de gespeelde kaarten **steeds hoger in waarde** zijn. De sprongen tussen opeenvolgende kaarten mogen zo groot of klein zijn als je wilt. Bijvoorbeeld 3, 11, 12, 13, 18, 20, 34, 35, 51. Of 2, 7, 19, 25, 28, 29, 49, enz. Probeer de sprongen zo klein mogelijk te houden, zodat er meer kaarten gespeeld kunnen worden.

Belangrijk: Voor de overzichtelijkheid worden de kaarten niet op de startkaart gelegd, maar in een **stapel ernaast**. Zo ontstaat tijdens het spel naast elke startkaart een stapel, waarvan steeds alleen de bovenste kaart zichtbaar is.



Voorbeeld:

Op deze in waarde stijgende stapel wordt eerst de 4 gespeeld, dan de 8, en dan de 13.

Bij een **in waarde dalende stapel** is het juist andersom. De gespeelde kaarten moeten dus steeds **lager in waarde** zijn. Bijvoorbeeld 94, 90, 78, 61, 60, 57. Of 98, 97, 88, 83, 81, enz.

Vorbereiding van het spel

Leg de vier startkaarten onder elkaar in het midden van de tafel. Schud de 98 speelkaarten. In een spel met 3, 4 of 5 spelers krijgt iedere speler 6 kaarten. In een spel met 2 spelers krijgen beide spelers 7 kaarten. Speel je alleen, dan krijg je 8 kaarten. Kaarten worden op hand genomen. Leg de overgebleven speelkaarten in een gedekte trekstapel links van de startkaarten.

Spelverloop

Bepaal, nadat alle spelers hun kaarten bekeken hebben, de startspeler. Vanaf de startspeler wordt met de klok mee gespeeld. De speler die aan de beurt is **moet minstens twee kaarten** uit zijn hand spelen. Hij speelt deze kaarten op een stapel naar keuze, rechts van de startkaarten.

Een speler mag meer dan twee kaarten spelen, hij mag zelfs al zijn kaarten spelen. De kaarten worden één voor één gespeeld. De speler bepaalt zelf steeds op welke stapel hij een kaart speelt (volgens de regels van Kaarten spelen). De speler kan alle kaarten op dezelfde stapel spelen, of **naar keuze op verschillende stapels**.

Voorbeeld: Arno is aan de beurt. Hij speelt een kaart op de bovenste stijgende stapel, vervolgens twee kaarten op de andere stijgende stapel en als laatste een kaart op de onderste dalende stapel.

Aan het einde van zijn beurt, trekt de speler kaarten van de trekstapel totdat hij weer precies 6 kaarten (bij drie, vier of vijf spelers), 7 kaarten (bij twee spelers) of 8 kaarten (als je alleen speelt) in zijn hand heeft. Daarna is de volgende speler aan de beurt.

Voorbeeld: Nadat Arno vier kaarten gespeeld heeft, beëindigt hij zijn beurt door vier kaarten van de trekstapel te pakken en deze op hand te nemen.
