Manent first describes a few essential features of democracy and the nation-state, and then shows how these characteristics illuminate many aspects of our present political circumstances. He ends by arguing that both democracy and the nation-state are under threat--from apolitical tendencies such as the cult of international commerce and attempts to replace democratic decisions with judicial procedures.

In other words, family rights simply disappeared into "the Rights of Man." In a radio broadcast in 1949 Pius XII said. "Counterfeiting God's designs in social matters has taken place at the very root, by deforming the divine image in man. For his true figure as a creature with an origin and destiny in God, has been substituted the false portrait of a man autonomous in conscience, uncontrolled master of himself, irresponsible towards his neighbor and the social group, with no destiny beyond the earth, with no purpose beyond enjoying finite goods, with no law beyond the 'fait accompli' and the undisciplined satisfaction of his desires."
