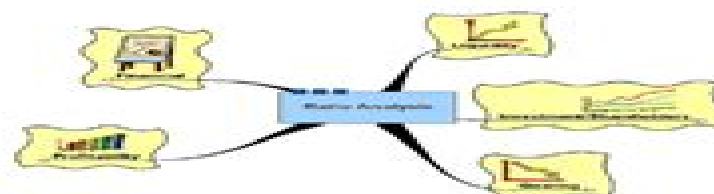

- Ratio Analysis
- Funds Flow Analysis
- Cash Flow Analysis
