Especially troubling, the authors stress, is that while overall economic

performance in the decades before the Great Recession was more than sufficient to broadly raise living standards, broad-based growth was blocked by rising inequality driven largely by policy choices. A determinedly data-driven narrative, *The State of Working America* remains the most comprehensive resource about the economic experience of working Americans.
