

# Reasoning from Evidence *Rules* (over all!) ...

Here's what we mean by these terms:

**Claim:** one-sentence statement relating two things. For example:  
*"The height of the balloon is a quadratic function of time."*

**Evidence:** stuff to which you will refer when explaining why your claim is true. For example:  
*Data tables, graphs, fitted equations, and previous claims that you have verified.*

**Reasoning:** explanation of how your evidence supports your claim. For example:  
*The plot of height vs. time data appeared to be quadratic and when we fit a quadratic to it using LoggerPro we found the resulting curve closely matched the data points.*

## How-To Tips:

Use a blank piece of paper to sketch a chain of claims leading from raw data to the resulting symbolic model. Use the chain to structure your writing.

1. We go from raw data to symbolic model... so narrate that trip.
2. Think of that trip as a sequence of steps... each step is a **claim** supported by **evidence** explained by **reasoning**.
3. For some claims, the reasoning will involve calculations.
4. **Good Form:**
  - Show your calculations, don't just give a numerical result.
  - Explain your calculations, don't just put numbers on a page.
  - Sequence reads like a story line, with a plot. Not a random walk.
