Taxation Law refers to any law that arises from the exercise of taxation power of the State.

1. Tax laws- these are laws that provide for the assessment and collection of taxes.
Examples:
 - a. The National International Revenue Code
 - b. The tariff and customs code
 - c. The local tax code
 - d. The real property tax code
2. Tax exemption laws- these are laws that grant certain immunity from taxation.
Examples:
 - a. The Minimum wage law
 - b. The omnibus investment code
 - c. Barangay micro-business enterprise law
 - d. Cooperative development act

Types of Administrative Issuance:

1. **Revenue regulations**, are issuances signed by the secretary of finance upon recommendation of the Commissioner of Internal Revenue; define rules and regulations for the effective enforcement of the provisions of the NIRC and related statutes. These are formal pronouncements intended to **clarify or explain the tax law** and carry into effect its general provisions by providing details of administration and procedures.
2. **Revenue memorandum Orders**, are issuances that provides directives or instructions; prescribe guidelines; and outline processes, operations, activities, workflow, methods,
