For the most part, these increases have resulted in positive improvements to life. The increased speed and volume of business activity creates more jobs, increases consumer satisfaction and reduces wasted time. For example, being able to e-file a tax return can save everyone concerned time and trouble. However, two important issues remain important in human interactions such as commerce (business activity). A notary's authentication is intended to be reliable, to avoid the inconvenience of having to locate a signer to have them personally verify their signature, as well as to document the execution of a document perhaps long after the lifetime of the signer and the notary. An oath is a sworn statement. In most cases a person will swear that a written statement, oral statement, or testimony they are about to give is true. A notary can document that the notary administered an oath to an individual.
